**Recent Events & Updates**

- Bay Area Open Space Council Gathering November 19, Berkeley on public funding opportunities. Anybody attend?

-MMWD board meeting on watershed funding, December 8, at which several of us spoke. The new watershed protection fee is estimated to cost average residential users \$5/month and bring in \$3.7M annually. The fee will increase by about 50 cents every year. Vegetation management and watershed maintenance components of the fee are charged to customers based on their meter size. Phil Sotter estimates, based on the 2012 draft vegetation management plan, that \$6-8M would be required to effectively manage broom and invasives, and he called on the board to commit to a 20-year plan for total eradication. Updated cost figures will be included in the new vegetation management plan.

-Status update: draft letter to the Board of Supervisors re the search for a new Parks and Open Space Director, stating our concerns to find a candidate with solid experience managing invasive species. New Interim Director Pat O'Brien from EBRPD; retirement of Ron Miska, Assistant Director. Nona will ask for the job description.

-Update on the 2010 Sonoma County Biodiversity Plan. There have been no significant followup documents, and the plan did not have a transformative effect. It is generally seen as a background document or reference. The county OSD is preparing a very good vegetation map, and many local organizations are active in the county and use the Plan as a background document. The county supervisors are still focused on economic development, however.
